## **Competencies or Objectives**

To update students' operational skills by involving them fully and directly in different situations in which they may be called upon to intervene as patrol officers within the context of their duties. While taking advantage of the methods and strategies of the experiential approach, they will be called upon to take an active part in basic training situations or in simple and complex reality situations.

## **Particularity**

During this course, participants must leave ENPQ and/or campus in uniform.

A 1.5 hour online pretest must be competed in the digital learning environment (Moodle).

This course is closely linked to the patrol officer's basic competencies and is a logical continuation within a maintenance of competence approach. Students will have to play an active role in their updating process. This will give them the opportunity to benefit from personalized and group coaching, as well as technical, methodological and operational reframing.

This course focuses on complex realities (physical and emotional intensity – unpredictability – stressors, etc.), which integrate a context of social tension (uncooperative citizen) and intervention with mentally disturbed people.

This course requires a certain amount of physical exertion. It is strongly recommended that the organization assess the student's health and fitness using the Physical Activity Readiness Questionnaire (PAR-Q) .

#### Risk Acceptance

From the time of reservation, registration and until the end of training, the organization certifies that the student is fit to take the course and accepts the inherent risks. The organization is responsible for cancelling a student's registration if the student's health and fitness are no longer sufficient for the course. Furthermore, ENPQ reserves the right to interrupt a student's training if it has reason to believe that the student's health and fitness are not adequate; ENPQ will inform the organization accordingly.

## **Competencies or Objectives**

To enable students to review their knowledge and professional attitudes necessary in correctly using a laser speed measuring device according to the particular specifications related to its use within the recognized jurisprudential framework.

## Prerequisite(s)

Police Traffic Lidar (Laser) [206-202-06] or Police Traffic Lidar (Laser) – Specific Concepts [206-303-06].

## Requirement(s)

- Must be a peace officer.
- Must have kept one's knowledge updated regarding the use of this device.
- Requalification is conditional on the successful completion of a diagnostic test to be performed at the beginning of the course as
  well as the achievement of all the minimal indicators stated on the certification evaluation grid. Students who fail the diagnostic
  test (passing score: 60 %) will not be allowed to continue the requalification process, but will be entitled to retake the test 30
  days later.
- During this period, their requalification is suspended and therefore they may not use a laser unit.
- If students fail the diagnostic test once again or the certification evaluation, they will be required to repeat the entire Police Traffic
  Lidar (Laser) [206-202-06] course or the Police Traffic Lidar (Laser) Specific Concepts [206-303-06] course, as the case may
  be.
- Students whose qualification expired on December 31 of the 5<sup>th</sup> year of their training may be requalified by a requalification instructor within the following six (6) months, i.e., until June 30 of the following year. However, during these six (6) months, they will not be authorized to use the device until they have been requalified. If they are still not requalified after this period, they will have to take the two-day course *Police Traffic Lidar (Laser) Refresher and Requalification* [206-307-16] given by an instructor within a period of no more than 18 months, i.e., until December 31 of the 7<sup>th</sup> year of the qualification.
